

Notice about School Attendance Support System for 2026

Osaki City Board of Education

In Osaki City, you can receive financial support to those who are having financial difficulties attending elementary or junior high school. If you would like to receive the Support, please read this notice and apply to the school.

■Those eligible for Support

Those who live in Osaki City, are parents of elementary and junior high school students, and meet any of the following conditions.

- 1 Those who receiving welfare benefits
 - ※ **Only School Trip and Medical Expenses** are provided.
- 2 Those who received any of the following measures this year or last year
 - a Suspension or cancellation of welfare benefits
 - b Municipal tax exemption
 - c Exemption from national pension insurance premiums
 - d Reduction or exemption from national health insurance tax
 - e Receiving Child Support Allowance
 - f Receiving a welfare loan from the Miyagi Prefectural Social Welfare Council
 - ※ If you meet conditions e or f, you will need to submit copies of the documents.
- 3 Those who do not meet conditions 1 and 2 but are experiencing financial difficulties.(See the Approval Standard Amount on the back)

※School Item for New admission and Commute Item Expenses will only be paid to those who are approved as of April 1st

※For those who are approved midway through the fiscal year, there are some expense items for which the amount will be calculated on a monthly basis and paid. In addition, Extra-curricular activities and School Trip Expenses will only be paid for events that are attended during the approval period.

※The grant amount is current as of Jun 2026 and subject to change.

■How to apply

- 1 Application forms are available at all Osaki City public schools. Please contact your child's school. (You will need to apply for each school , so if student's siblings attend both elementary and junior

- high school, you will need to apply separately to each school.)
- 2 Please fill out the application form, attach the necessary documents, and submit it to the school. (Welfare recipients do not need to submit an application.)
 - a School Attendance Support System Application Form (Form No.1)
 - ※ All household members, excluding those under 18, must sign a consent form.
 - b Bank Transfer Request Form (Form No.18)
 - c Copy of Bankbook ※ Please submit even if there are no changes from last year.
 - d Power of attorney (Form No.7)
 - e Documents certifying your eligibility if you fall under 2-e or f of “Those eligible for support”
 - f Disaster victim certificate (Only those who are attending school in Osaki City due to the effects of the disaster.)
 - ※ By writing your My Number on the application form, you can omit attaching documents to prove your income status. **However, if you were registered as a resident in another city or town outside of Osaki City as of January 1, 2026, you will need documents to prove your income.**
 - ※ Those who were approved in 2025 and those who applied for School Item for New admission Expenses in 2026 will also need to apply again. If you wish to continue receiving the support this year, please be sure to apply.

■Application acceptance period

Please submit the application form to the school **by April 16, 2026**.

- ※ Applications are accepted after the deadline, but there are some items that are not eligible for payment.

■About Approval and Payment

- 1 Based on the application, the Board of Education will conduct a judging and notify the school in writing of the approval or disapproval **in mid-July**. (If you apply mid-year, you will generally be notified of the result of your application the month following the month of application.)
 - ※ The criteria for determining eligibility is whether your Total Income / Net Income in 2025 is below the Approval Standard Amount listed below.
- 2 Support Expenses will be paid to approved recipients three times a year: in **late July, mid-December, and mid-March**.

■Point to note ※Please read.

- 1 In principle, approval or disapproval is determined based on the income of all members of the same household. However, even if a person is living separately due to working away from home, they will still be considered to be in the same household.
- 2 If you are required to file a tax return, please be sure to complete it by the deadline. If your income status cannot be confirmed, your application cannot be reviewed.
